PROCESS AND TERMS

OUR PROCESS

- 1) Booking: New owner books pup with 50% deposit and provides personal info and address to us via completed booking form. Verbal booking is not binding on the Breeder unless this step is complete.
- 2) Selection: New owner is informed of birth of pups and updated until 28th day of age when owner selection is allowed (refer to terms below)
- 3) Updates and Release Notification: We keep all owners up to date via the [litter info page](#). We then notify the owner of their puppy 'release ready' date
- 4) Admin: We complete vet-compliant check, deworming and vaccinations @ 6 weeks of age
- 5) Pickup: Owner settles balance and arrange transport of pup for within 7 days of 'release ready' date
- 6) Registration: We complete registration with KUSA and send you the papers with registered post
- 7) Transfer: New owner to notify KUSA of ownership change via registered post
- 8) Follow up: Please keep in touch with us!

PROTECTING YOUR PUP, INTERESTS AND OURS – TERMS, CONDITIONS AND DISCLOSURE

- 1) Pre-booking is only valid after our receipt of the full amount and following specification of your choice of sex and color. Completing this document makes you liable for the said deposit within 72 hours.
- 2) Should no pup be born to match your criteria, the full amount is refundable within 2 working days of your request to do so or alternative preference will be given to you for pup selection:
- 3) You are given opportunity to assess/choose a pup from those matching your criteria or those available/not booked yet by the 28th day following birth.
- 4) All individuals with pre-bookings are given preference of assessment selection choice for 5 days until the pups are 35 days of age, by choice of electronic communication or in person at our Kennel, in the order that pre-bookings were made by the relevant individuals.
- 5) Thereafter, we retain our right to release your pup on our discretion of health and development and will advise accordingly.
- 6) After birth and before your pup leaves our Kennel, we will update you on his/her health and development on a weekly basis, but we are not obligated to preserve the life of any pup in the case of life-threatening circumstances. Should unfortunate circumstances lead to the death of your pup during this period, we will refund 100% of the paid amount to you within 2 working days.
- 7) We cannot guarantee or assure the condition or health of your pup in any way from the date that the pup leaves our Kennel and the new owner bares the responsibility of future vaccinations and the protection of the pup.
- 8) We will not sell you a male(dog) and female(bitch) from the same litter unless you sign an agreement to have both spayed/neutered and for a breeding restriction to be placed on both with KUSA.
- 9) The full amount for each pup must be settled and receipt confirmed by us before the pup leaves our Kennel.
- 10) We undertake to act in accordance with preferred breeding standards.
- 11) We retain our right to follow up with all implied parties and bodies on the registration and condition of any pup and of any further offspring produced from our litters.
- 12) Microchip ownership transfer must be requested by the new owner online via the relevant chip issuing body www.getmeknown.co.za / www.identipet.co.za
- 13) You fully accept all these terms and our processes by engaging with us.
